Ahmed Bazoon (based in Bulgaria)	Ahmed is an electrical engineer from Iraq. He worked in the independent press for 8 years in addition to his work in construction and decoration. He has been living in Bulgaria since 2015 and has worked in local NGOs for 7 years. Ahmed is the Representative of the Refugee Advisory Board Association (RAB) and a Member of the Arabic Committee for Integration.
Anila Noor (based in the Netherlands)	A refugee feminist leader, Anila is the co-founder of the GRN, a GIWRL Policy advisor on diversity, integration & gender inclusion, and a member of the expert group on the views of migrants in the field of migration, asylum & integration. She is also a fellow of OSF, FFVT, KAICIID, and a consultant for the World Bank, the EU Commission, and UN Agencies on meaningful participation.
Apajok Biar (based in Australia)	Apajok was born in a refugee camp in Kenya and arrived in Australia with her family at the age of two. She is the chairperson and co-founder of South Sudan Voices of Salvation Inc., and co-founder and member of Angaac women association Australia inc., supporting women in South Sudan and Australian based South Sudanese and Angaac community women. She is on the board of the Women's Museum of Australia, and a member of the Gender Audit team to UNHCR. Apajok was also recently appointed as the Chair for the Women's, Gender and Diversity working group with the Asia Pacific Refugee Rights Network. She has received various awards including the 2017 Western Sydney Refugee Youth Award, and the Myan Refugee Youth Scholarship as the Refugee Youth Advocate representative for Australia & New Zealand at UNHCR. She holds a Bachelor of Social Work and is undertaking a Masters on Humanitarian Assistance at Deakin University. She works as a social worker and is a mother of a beautiful 2-year-old girl.

As a member of the CCE Coalition Creating Equity, Izdhar has been actively advocating for equity and inclusion in Canada, fighting against discrimination and promoting a more just and compassionate society.
Joseph Youhana (based in Australia)	Joseph is a recognised global advocate for refugee issues since 2010. He holds a bachelor's in applied management and over 16 years of experience in the Australian NGO management sector. He is the State Director for the HOST International since 2022, and a founder of many initiatives including the only Assyrian peak refugee-led organisation (Australian Assyrian Chaldean Syriac Advocacy Network). In 2021, he was recognised as the Citizen of the Year for the Hume City Council in Victoria. Julia Sheikh (based in New Zealand)	Originally from Pakistan, Julia (Ismat) arrived in New Zealand as an asylum seeker with her family at the age of 10. She is currently the Clinical Team Leader for the Refugees as Survivors NZ (RASNZ) Community Mental Health team in Auckland. She is also a fully registered counsellor with expertise in trauma and culturally informed mental health care, and has a background in crisis intervention, providing clinical support to the Christchurch Mosque attack victims. Among other experiences, she has worked with Shakti, the Fatima Foundation, the Salvation Army, and NZ Police ethnic liaison officers to provide a safe place for refugee women and children at risk. Julia also works for Youthline, supporting youth with mental health issues. One of her main goals is to help people from refugee backgrounds get into employment. She previously served in homeland security with a focus in counterterrorism and counterintelligence and as an adjunct professor at two universities. She's a TEDx Presenter and is active in various advocacy roles including being a Refugee Congress Honorary Delegate, a member of the White House Initiative on Asian Americans, Native Hawaiians, and Pacific Islanders, a Vice-Chair of the Program Services Committee for the Lutheran Family Services Rocky Mountains Board of Directors, and a Noble Ambassador for Christina Noble Children's Foundation. Nga's advocacy work was recognized by UNHCR for AAPI Heritage Month in a spotlight story Badge of Honor, and she has received the Colorado Attorney General's Award for Outstanding Community Service.
Nhial Deng (based in Canada)	Nhial is a South Sudanese refugee, writer, youth advocate, community activist, and organizer. He is passionate about the role of education, mentorship, and social entrepreneurship as powerful tool for refugee youth, and advocates for education, intersectional feminism, social justice, and meaningful youth engagement. Nhial is providing advice to governments, international humanitarian organizations, foundations, universities, and the private sector on issues ranging from refugee education to DEI (diversity, equity, and inclusion) and gender justice to peacebuilding. Noor was named one of YAIA's 2022 Young Women to Watch in International Affairs and was selected as an Australian delegate for the Young Pacific Leaders Conference 2023.
Rabia Mohamad Talal Almbaid (based in New Zealand)	Rabia is a former refugee from Syria who has called New Zealand home since 2017. He has a background in Leadership and Applied Management. He currently works with the New Zealand Police as a Senior Partnerships Advisor. Rabia is part of the New Zealand Refugee Advisory Panel, and brings insights of lived experience into working with NGOs and government agencies.

Rez has worked in Iraq as a Harvard Human Rights Fellow in support of cases prosecuting ISIS for its genocidal campaign against the Yezidis. She is the founder of 'Empower' and a member of R-Seat. She represented New Zealand at the first Global Refugee Youth Consultations in 2016 and helped establish the Global Youth Advisory Council to the UNHCR. Rez has also received various awards including 2017 Young New Zealander of the Year, 2019 Outstanding Youth Delegate Award at the UN Youth Assembly, and 2021 Peace Ambassador for the One Young World Summit.

Seconde Nyanzobe (based in Canada)

Seconde is a refugee serving refugees, a peacebuilder and human rights defender. She holds a diploma in teaching French language, social psychology and Canadian Immigration Law. She is a co-founder and advocacy officer at ISOKO Partners for Peace and Gender Equality and a GRN board member. Seconde has been advocating for the implementation and localization of the UN Resolutions 1325 and 2250 related to Women, Youth, Peace and Security. She is working for a community-based organization in Canada as a resettlement advisor and resettlement case manager.

Shaza Rihawi (based in Germany)

Shaza is a human rights activist and Syrian refugee. She is a co-founder, Steering Committee member, and Chairwoman of the Global Refugee-led Network, a member of the Gender Audit team for UNHCR, the co-founder of Network for Refugee Voices, and a former member of the European Migrant Advisory Board. She is also a board member of New Women Connectors and the co-founder of Global Independent Refugee Women Leaders. Previously, Shaza worked with the United Nations Relief and Works Agency (UNRWA) and the Centre for Strategic Studies in Syria. Syed Hasnain (based in Italy)

Syed was born in Afghanistan. After fleeing at the age of ten, he went through Pakistan, Iran, Turkey and Greece until he finally reached Italy in 2007 where he was recognized as a refugee. He started taking Italian lessons and engaging with refugees, asylum seekers and unaccompanied minors as a social worker, cultural mediator, and legal adviser. Syed has worked with several humanitarian NGOs (Save the Children, Jesuit Refugee Services, INTERSOS and MSF). In 2019, he co-founded the European Coalition of Migrants and Refugees to advocate for refugee involvement in policy making. In April of the same year, together with other six refugees, he founded the first national union of refugees in Italy (UNIRE) to shift the narrative around refugees. As a UNIRE president, Syed is a member of the expert group on the views of migrants in the field of migration, asylum and integration at the EU Commission. In addition to his other roles, Syed is currently working as project officer and social media manager with Missing Children Europe organization on Miniila App, an application providing legal information and
